## PROPOSED FARE CHANGES EFFECTIVE MARCH 1, 2016.

The purpose of the hearing is to allow public comment on proposed increases to senior, disabled, youth and SHUTTLE fares. The new fares, if adopted, would be implemented March 1, 2016.

Youth Local One-Ride Tickets*	\$0.75	\$1.00
Youth Monthly Pass	\$27.00	\$36.00
SHUTTLE Cash Fare	\$0.75	\$1.25
SHUTTLE One-Ride Tickets*	\$0.75	\$1.25
SHUTTLE Monthly Pass	\$27.00	\$45.00

*\* Certified Human Service Agencies may purchase tickets. Tickets are not available to the general public.*

**All other fares would remain the same.**
