PRESENTATIONS

2016 Ridership Report

Senior Planner Max Henkle gave an overview of the 2016 annual ridership for fixed route, SHUTTLE and vanpool monthly boardings. He noted ridership is following nationwide trends, decreasing 6 percent since 2015. (Commissioners Bruce Dammeier and Don Anderson arrived at 4:15 p.m.)

A discussion ensued regarding the consistencies between Pierce Transit and national bus ridership data. Upon inquiry, CEO Sue Dreier noted bus ridership being down all across the nation and agreed to share related data with the Board at a later date from her recent trip to the American Public Transportation Association (APTA) Transit CEOs Conference. Ms. Dreier assured the Board that Pierce Transit is continually looking at how to best meet the needs of their customers.

Prior to Commissioner Bruce Dammeier providing his feedback on the ridership report, Chair Keel welcomed him to the Pierce Transit Board and congratulated him on being elected Pierce County Executive.

Fourth Quarter (2016) Major Capital Initiatives Report

Project Management Office Manager Heidi Soule gave an overview on the status of 12 major capital projects with a budget of \$1 million or more.

Chair Keel requested that staff include completed projects in this report moving forward.

Fourth Quarter (2016) CTAG Report

Community Transportation Advisory Group (CTAG) Chair Chris Karnes reported on the efforts that the group has been working on relating to the upcoming March 2017 service change, Comprehensive Route Analysis and Pacific Avenue High Capacity Transit (HCT) project. Mr. Karnes noted that CTAG has recently received several updates from Pierce Transit staff on major initiatives, and some CTAG members will be participating in the service change transit outreach events on March 8, 9 and 13.

PUBLIC COMMENT

Chair Keel provided direction for participating in public comment and the following individuals spoke:

- Cinderella Helga, Lakewood, reported an inconsistency with being told whether riders traveling on the Sound Transit 594 bus are allowed to bring suitcases onto the bus. Ms. Helga also expressed her concern with the 48 bus no longer being available outside of the Pierce Transit headquarters building.
- Marina Becker, Tacoma, Director with Metro Parks, spoke in support of the upcoming Downtown to Defiance Trolley pilot service project. Ms. Becker expressed her appreciation for the consideration of this pilot project, staff working on this project and partnership with Pierce Transit. Ms. Becker noted Metro Parks will bring communication and marketing resources in this partnership to create a public awareness.

Commissioners Dammeier and Strickland <u>moved</u> and seconded to approve Resolution No. 17-005 authorizing the operation of the seasonal Downtown to Defiance pilot service and authorizing the Chief Executive Officer to enter into and execute the agreement with the City of Tacoma and Metro Parks for a pilot service to test seasonal Downtown to Defiance Trolley service.

Community Development Administrator Tina Lee reported on the proposed pilot service project that would offer a special fare to riders and run June 2, 2017 through September 3, 2017. Ms. Lee noted that this one year pilot will help Pierce Transit learn whether there is a desire to have this type of service and what the operational challenges are for this corridor.

A question and answer period ensued regarding the rationale behind the special fare to riders, route and stop details in comparison to other local transportation options, and whether Pierce Transit could track the origin of the rides and track data for local ridership versus non local ridership.

Staff noted that a survey will be conducted after the service is underway and the results will be provided to the Board. Upon inquiry, staff also noted that the pilot service will be advertised in every jurisdiction and information will also be provided at the Washington State Spring Fair.

The Board thanked Pierce Transit staff for their efforts on this project and expressed their excitement.

STAFF UPDATES/DISCUSSION

CEO's Report

CEO Sue Dreier reported on the following items:

- Agency staff has been working with the Athena Group in preparation for the upcoming February 22, 2017 Board Retreat. Ms. Dreier noted the potential for an additional session if there is not enough time to cover all of the agenda items.
- Recognition was given to agency vehicle maintenance personnel after two MCI coaches recently caught on fire. Agency mechanics alleviated the safety issue for Pierce and Sound Transit after an unsuccessful attempt was m by the manufacturer to provide a successful fix.
- "More to Smile About!" is the theme for the upcoming Spring 2017 service change communications and marketing campaign. In keeping with that theme agency service change Street Teams will hand out "smiles" to riders. Smile stick props that will be given out to customers during the first two weeks of service were passed out to the Board for review and pictures were taken by the agency's Public Relation Officer as the Board shared their excitement for the campaign.

Sound Transit Update

Commissioner Strickland reported that Sound Transit is making massive improvements and she is challenging the Tacoma region to make sure the city has the workforce to fulfil these projects.

Chair Report

Chair Keel reported that he will be joining the Sound Transit Board. There will now be three Pierce Transit Board members representing Sound Transit, the Puget Sound Regional Council (PSRC) and the Pierce County Regional Council (PCRC). Chair Keel advocated Board members in those venues to work together for the betterment of Pierce Transit.

Commissioners' Comments

Commissioner Henderson thanked CEO Sue Dreier for the beneficial monthly reports she sends to the Board. She also described her recent experience while on a Pierce Transit police ride along and noted she was very impressed by the Deputy's alertness and attention to quality of life issues, such as smoking at bus stops. Commissioner Henderson expressed her gratitude to all of Public Safety and Police Officers for their daily acts of bravery.

EXECUTIVE SESSION

At 5:11 p.m. the regular meeting was recessed into Executive Session for approximately 15 minutes to discuss pending litigation, pursuant to RCW 42.30.110 (1)(i). It was noted that formal action would not occur in open session following the executive session.

Explanation: The cost estimate for the lease of tires for transit bus fleet contract is the base price of \$728,175 for the first year. This is based on the actual bid received. The estimate for the second (2nd) through seventh (7th) years are: year two (2) \$750,021; year three (3) \$772,521; year four (4) \$795,697, year five (5) \$819,568, option year six (6) \$844,155, and option year seven (7) \$869,479 based on a maximum three percent (3%) yearly increase over term of contract not to exceed \$5,579,616.

BACKGROUND:

The Invitation for Bid was released on January 11, 2017 and was posted on the eBids website, advertised on Pierce Transit's website, The Daily Journal of Commerce, Tacoma Daily Index, the Office of Minority & Women's Business Enterprises (OMWBE) and Transit Talent. There were six (6) companies that downloaded the bid documents. Pierce Transit received clarification questions from the three (3) major companies. A public bid opening was held and representatives from two companies were in attendance. One (1) bid was received on-time and was determined responsive from Bridgestone Americas Tire Operations, LLC and one (1) bid was received after the bid opening time and was therefore determined non-responsive.

Four (4) Pierce Transit employees completed a thorough review of the bid price proposal and the responsiveness criteria set forth in the bid. Staff concurred that Bridgestone Americas Tire Operations, LLC's price proposal was fair and reasonable and that Bridgestone Americas Tire Operations, LLC is able to meet the requirements of the bid. Additionally, Bridgestone Americas Tire Operations, LLC currently provides tire leasing and service to several local transit agencies such as King County Metro, Spokane Transit Authority, and Ben Franklin Transit.

ALTERNATIVES:

The alternative would be to reject the bid and start the procurement over. This is not recommended as staff has confirmed the bidder meets the standards of Pierce Transit and is a responsive and responsible bidder. The price is already in aligned with existing costs and has been determined to be fair and reasonable.

RECOMMENDATION:

Authorize the Chief Executive Officer to enter into and execute a multi-year contract with Bridgestone Americas Tire Operations, LLC for lease of tires for transit bus fleet for five (5) years, with two (2) optional one-year extensions for an approximate cost of \$5,579,616 if both option years are utilized.

Explanation: This amendment increased the Capital Project Vanpool Replacement 2017 Project which includes grant funding in the amount of \$679,417 and authorizes the purchase of fifty-five (55) Vanpool vehicles. The additional requested funds are available from capital reserves.

BACKGROUND:

This resolution seeks authority to purchase fifty-five (55) replacement Vanpool vans: thirteen (13) 7-Passengers, twenty-nine (29) 12-passenger, and thirteen (13) 15-passenger replacement Vanpool vans from Washington State Contract No. 05916 in March 2017.

The Agency budget for 2017 includes funding for thirteen (13) 7-Passengers, twenty-nine (29) 12-passenger, and thirteen (13) 15-passenger Vanpool replacements (Replacement policy: 7 years or 120,000 miles). The vans being replaced are 11-years old with average mileage of 131,598 and are consistent with Pierce Transit's Replacement Policy. The State of Washington has established vehicle contracts that allow use by political subdivisions and these contracts are currently available for use. Staff has reviewed the contracts available and has identified vehicles appropriate for our intended purpose.

Vehicles to be purchased include 7-passenger Dodge Grand Caravans, 12-passenger Chevrolet Express 3500 vans, and 15-passenger Chevrolet Express 3500 vans. State contract pricing is obtained on a competitive bid basis and is considered to be fair and reasonable. Federal Grant funds in the amount of \$679,417 will be used to purchase these vans.

ALTERNATIVES:

Develop specifications and solicit bids ourselves; however, in the past we were not able to achieve the deep discounts offered in the state contracts due to statewide purchasing volume.

RECOMMENDATION:

Approve Resolution No. 17-006, amending the 2017 Capital Budget to increase the Vanpool replacement 2017 project budget and authorizing the purchase of fifty-five (55) replacement vanpool vans from Washington State Contract No. 05916.

WHEREAS, Washington State Vehicle Contract No. 05916 was competitively bid and the cost is considered to be fair and reasonable; and

NOW THEREFORE, BE IT RESOLVED by the Board of Commissioners of Pierce Transit as follows:

Section 1. The 2017 Capital Budget is herewith amended to increase the Vanpool Replacement 2017 Project by \$25,000, from \$1,714,292 to \$1,739,292.

Section 2. The Chief Executive Officer is hereby authorized to purchase fifty-five (55) replacement Vanpool vans: thirteen (13) 7-passenger, twenty-nine (29) 12-passenger, and thirteen (13) 15-passenger vans from Washington State Contract No. 05916 in the amount of \$1,739,292.

Explanation: The current Maintenance Agreement expires on April 20, 2017. The new Agreement locks in maintenance and support costs for our automated scheduling and dispatch system for the next three years. The budget amount includes the 2017 Agreement fee. Year 2 and 3 fees will be budgeted in the 2018 and 2019 budgets. Funds required for 2017 are included in the 2017 Maintenance and Operations budget. Costs for 2017 exceed the original budgeted amount by \$2,589 due to the fact additional Hastus modules were purchased for the 2017 system upgrade and this increase was not known during the budget process. This overage will be covered under systems enhancement funds in the IT M&O budget. Costs for 2018 and 2019 are \$192,957 and \$197,778 respectively. Total cost of the 3-year agreement is \$605,675 (including tax).

BACKGROUND:

This resolution requests authority to execute a three-year Maintenance and Support Agreement for our current automated scheduling and dispatch system with GIRO, Inc.

Pierce Transit uses a computer-aided system to plan, schedule, dispatch, and manage its fixed route bus service. This system allows Pierce Transit to optimize the use of staff and equipment. The scheduling system generates and stores all of our transit trips, assigns vehicles to operate the trips and assigns pieces of work for transit operators. The system is also the timekeeping system for our transit operators and maintenance personnel, and is the source of all timekeeping data that is passed to our Payroll System for payroll processing. The system is a critical part of our business.

The original system was purchased from GIRO 31 years ago. The current three-year Maintenance Agreement expires on April 20, 2017. We have negotiated a new three-year maintenance and support agreement that locks in maintenance and support costs for a three year period.

GIRO, Inc., is the proprietory vendor for this software and is the only firm that can provide maintenance and support for the system. They have provided superior service over the years. This system and its related modules are also successfully in use at King County Metro and Community Transit, which greatly eases coordination as regional projects develop. Staff conducted a price comparison with other users and has found that the price proposed for the Maintenance and Support Agreement is fair and reasonable.

ALTERNATIVES:

The alternative would be to enter into a costlier single year Maintenance Agreement, however savings realized from a multiyear agreement would be lost.

RECOMMENDATION:

Authorize the Chief Executive Officer to enter into and execute a 3-year Sole Source Maintenance and Support Agreement with Giro, Inc., for maintenance of the automated scheduling and dispatch system.

BACKGROUND:

This resolution requests ratification of the Chief Executive Officer's Declaration of Emergency made on February 17, 2017 in response to a motor vehicle accident that took place at the Tacoma Mall Transit Center.

At approximately 3:30pm on Monday, February 13th, 2017, a private vehicle veered from the road and struck the Tacoma Mall Transit Center, located at 2508 47th Street, Tacoma, WA 98409. The vehicle struck a transit shelter structure, light pole, seating, and other amenities which caused significant damage. The Transit Center is accessed by many and is located next to the Tacoma Mall, which is a highly used transit location. The damage to the property resulted in a real, immediate threat to the proper performance of essential functions as well as a material loss or damage to property.

Therefore, in accordance with RCW 39.04.280 and Pierce Transit Code Section 3.13.08 – Emergency, the Chief Executive Officer has declared the existence of an emergency allowing suspension of competitive bid procedures and execution of contracts necessary to complete the repair work needed to restore the facility to a safe condition. Although competitive bid processes will be suspended, the Chief Executive Officer will ensure that all other Public Work rules and regulations are adhered to and will keep the Board informed of any contracts executed to remedy the emergency.

ALTERNATIVES:

The alternative would be not to ratify the Chief Executive Officer's finding of an emergency. However, work on the facility must be completed expeditiously to eliminate risk of injury and loss to the agency.

RECOMMENDATION:

Approve Resolution No. 17-007, ratifying the declaration of emergency related to Tacoma Mall Transit Center damage due to a Motor Vehicle Accident, and authorizing expenditures in an amount not to exceed \$75,000.00 for the repair of the facility.

BACKGROUND:

\$10,000

In 1991, the Washington State Legislature passed the Commute Trip Reduction (CTR) law (RCW 70.94.531) impacting employers with 100 or more employees. The goal of CTR is to improve transportation system efficiency, conserve energy, and improve air quality. The law requires employers to develop effective transportation programs that encourage the use of non-drive alone transportation options.

Pierce Transit contracts with Pierce County and the City of Tacoma to work directly with employers to meet the CTR requirements. The Agency works with 180+employer partners providing a suite of programs and services. Campaigns such as "Wheel Options" and the "Relax Rewards" incentive programs have proven to increase

participation in CTR programs by offering incentives to individuals who track their commute modes on the PierceTrips website. Incentives are generally small prizes of gift cards valued at \$5 to \$25 per prize. Each participating employee can receive up to \$50 in rewards annually.

In 2016, 2,150 employees from 106 employers in Pierce County regularly participated in CTR and logged their trips at PierceTrips. Last year, the incentives program cost approximately \$19,000, funded by Pierce Transit (\$3,000) and Congestion Mitigation and Air Quality (CMAQ) grants (\$16,000). For this relatively small investment, the Agency is able to track that commuters took 322,000 non-drive alone trips, traveled 6.1 million non-drive alone miles, and saved 4.7 million pounds of CO2 emissions. The incentive portion of the Agency's CTR program represents a cost of less than \$9 per participant. The goal for the incentives program is to increase the number of commuters logging trips and miles. With the additional authority requested by this resolution, Agency staff aims to grow the number of new CTR participants and hopefully implement a milestone program to encourage existing users to continue or increase their participation. Staff estimates that the CTR program could grow by 10% each year by 2020, for a total of 3000 annual participants.

On September 1, 2016, the Federal Highway Administration reinterpreted the rules for CMAQ funding, such that most incentive programs are no longer eligible. CMAQ grant funds will instead be used for other CTR program needs. Resolution No. 99-025 authorized the CEO to expend up to \$1,000 in support of county-wide CTR programs. Given the passage of time, a renewed focus on alleviating congestion, and since CMAQ funds are no longer available for these incentive programs, staff seeks to increase the CEO's authority to provide local funds of up to \$30,000 to maintain and grow the success of CTR programs. The CTR incentives program budget would be approved annually through the budget process, and the effectiveness of the incentives program will be re-evaluated annually. In 2017, the Employer Services budget allocates \$10,000 to this CTR incentive program.

Authorizing the Chief Executive Officer to provide up to \$30,000 per year, as approved by the annual budget, will affirm Pierce Transit's commitment to increasing ridership, reducing congestion, conserving energy and improving air quality.

ALTERNATIVES:

Declining authorization will require the Agency to decrease its investment in the CTR incentives program which may increase drive alone trips and reduce Pierce Transit's ridership.

RECOMMENDATION:

Approve Resolution No. 17-008, repealing Resolution No. 99-025, Authority to Provide Awards up to \$1,000 Annually for County-wide Commute Trip Reduction Participation; and

WHEREAS, In 2016 a \$19,000 incentives investment allowed Pierce Transit to track that commuters took 322,000 non-drive alone trips, traveled 6.1 million non-drive alone miles, and saved 4.7 million pounds of CO2 emissions; and

WHEREAS, the majority of the funding for CTR incentives has previously come from various Congestion Mitigation and Air Quality (CMAQ) grants that are no longer eligible for reimbursement for this purpose; and

WHEREAS, Pierce Transit plans to continue CTR efforts and rewards programs to incent individuals to utilize public transportation options; and

WHEREAS, Resolution 99-025 which authorized only \$1,000 for CTR participation incentives is outdated and no longer provides sufficient financial authority to allow staff to fully engage Pierce County commuters in CTR efforts; and

NOW THEREFORE, BE IT RESOLVED by the Board of Commissioners of Pierce Transit as follows:

<u>Section 1</u>. The Board of Commissioners hereby repeals Resolution 99-025, Authority to Provide Awards up to \$1,000 Annually for County-wide Commute Trip Reduction Participation; and

<u>Section 2</u>. The Board of Commissioners hereby authorizes up to \$30,000 annually, as approved by the annual budget, to provide awards for county-wide Commute Trip Reduction participation programs.

Explanation: The study will be funded with \$200,000 Pierce Transit funds and \$32,000 provided by the City of Tacoma from a National Endowment for the Arts grant.

BACKGROUND:

This resolution requests authority for the CEO to enter into an intergovernmental agreement with The City of Tacoma for \$32,000 to administer a consultant contract for creation of a Tacoma Theater District Culture and Transportation Plan. This resolution also requests authority to award a consultant contract to Walker Macy for conducting the work.

Pierce Transit partnered with the City of Tacoma and the Broadway Center for Performing Arts (BCPA) for a Creative Placemaking grant to conduct this project. As the eligible grant recipient, the City was awarded \$50,000 from the NEA's "Our Town" Program. The City will pass \$32,000 through to Pierce Transit to administer the consultant contract and the City will directly administer \$18,000 of the grant amount to fund the artist engagement portion of the project in partnership with Spaceworks Tacoma (a joint initiative of the City of Tacoma and the Tacoma-Pierce County Chamber of Commerce which provides opportunities to artists and entrepreneurs).

The project will create a Tacoma Theater District Transportation & Culture Plan with the aim of bringing about a vibrant, visually appealing destination for cultural, artistic, civic, and local marketplace activities, a destination that is well-served by multiple forms of transportation and offers convenient transit connections. Important dimensions of the plan will be to consider the role of public transportation and how it can best support and enhance the cultural activities in this location, as well as how art and cultural activities can best complement public transportation. The project provides for stakeholder engagement, plan development, technical studies and conceptual designs that will leverage the existing public investments and attract additional public and private investments to the district.

Each of the partners owns or operates significant assets that can contribute to economic development and revitalization of this district. This project is an opportunity to use best practices in urban design, creative placemaking, transit oriented development, and public art to better connect the transit hub with the BCPA and other cultural activities, increase pedestrian flow, and foster economic vitality. The expected outcome will create a safe sense of place where community members want to gather and express themselves, enhance this district, and strengthen access and usability of the publicly owned spaces in this urban center.

A Request for Proposals/Request for Qualifications (RFP/RFQ) for the consultant contract was released on August 31, 2016. Statements of Qualifications and Proposals were due by October 4, 2016. Pierce Transit received 12 proposals and interviewed the top three (ranked and scored) consultant teams. After careful review of the firms' qualifications and proposals, the selection committee chose Walker Macy and negotiated the scope of work and fees for the project. The contract with Walker Macy is for an amount not to exceed \$232,000.

This project will result in a plan and concepts that will guide further design work, public investment, and encourage well-thought-out and appropriately planned private development. In-kind commitments from all partners, including Pierce Transit, City of Tacoma, and BCPA staff time, event space, and expertise, show real commitment from the partners to make this project a success.

ALTERNATIVES:

An alternative would be to not conduct the study. However, Pierce Transit has committed to at least \$50,000 match for the NEA grant, so the partners would risk loss of the \$50,000 in grant funds. In addition, PT's Commerce turnaround facility is in need of significant mid-life maintenance. Leveraging those future necessary maintenance funds for a project that enhances the facility and the district in a transformative way will put those future funds to greater use. The investment in this study sets the stage for how to best spend those funds.

SERVICES CONTRACT

THIS CONTRACT, made and entered into effective as of the _____ day of March, 2017 ("Effective Date") by and between the **CITY OF TACOMA**, a municipal corporation of the State of Washington (hereinafter referred to as the "CITY"), and Pierce County Public Transportation Benefit Area Corporation (Pierce Transit), a Washington State public-benefit corporation (hereinafter referred to as "CONTRACTOR");

1. Scope of Services/Work

A. 2. Term

- **A.** All services shall be satisfactorily completed on or before December 31, 2018 and this Contract shall expire on said date unless mutually extended in writing by the Parties.
- **B.** Neither party shall be considered to be in default in the performance of this Contract to the extent such performance is prevented or delayed by any cause which is beyond the reasonable control of the affected party and, in such event, the time for performance shall be extended for a period equal to any time lost as a result thereof.

3. Compensation and Payment

- **A.** The CITY shall compensate the CONTRACTOR for the services and deliverables performed under this Contract in accordance with Exhibit A.
- **B.** The total price to be paid by CITY for CONTRACTOR'S full and complete performance of the Scope of Work hereunder shall not exceed \$32,000 without the written consent of the CITY. Said price shall be the total compensation for CONTRACTOR'S performance hereunder including, but not limited to, all work, deliverables, materials, supplies, equipment, subcontractor's fees, and all reimbursable travel and miscellaneous or incidental expenses to be incurred by CONTRACTOR.
- **C.** Payment shall be made upon satisfactory completion of the Culture and Transportation Plan described in Exhibit A and will be made through the CITY'S ordinary payment process, and shall be considered timely if made within 30 days of receipt of a properly completed invoice.
- **D.** The CITY may withhold payment to the CONTRACTOR for any services or deliverables not performed as required hereunder until such time as the CONTRACTOR modifies such services or deliverables to the satisfaction of the CITY.
- **E.** All payments shall be subject to adjustment for any amounts, upon audit or otherwise, determined to have been improperly invoiced.

F. In the event the CONTRACTOR incurs cost in excess of the sum authorized for service under this Contract, the CONTRACTOR shall pay such excess from its own funds, and the CITY shall not be required to pay any part of such excess, and the CONTRACTOR shall have no claim against the CITY on account thereof.

4. Independent Contractor Status

- A. The services and deliverables shall be furnished by the CONTRACTOR as an independent Contractor, and nothing herein contained shall be construed to create a relationship of employer/employee or master/servant. No payroll or employment taxes of any kind shall be withheld or paid by the CITY with respect to payments to CONTRACTOR. The payroll or employment taxes that are the subject of this paragraph include, but are not limited to, FICA, FUTA, federal income tax, state personal income tax, state disability insurance tax and state unemployment insurance tax. 7. Termination and Suspension

- **A.** Either party may terminate this Contract at any time, with or without cause, by giving ten (10) business days written notice to the other party. In the event of termination, all finished and unfinished work prepared by the CONTRACTOR pursuant to this Contract shall be provided to the CITY. In the event either party terminates this Contract without cause due to the other party's actions or omissions, the terminating party shall pay the other party the amount due for actual work and services necessarily performed under this Contract up to the effective date of termination, not to exceed the total compensation set forth herein.
- **B.** Termination or suspension of this Contract by either party shall not constitute a waiver of any claims or remaining rights either party may have against the other party relative to performance hereunder.

8. Taxes, Licenses and Permits

- A. The CONTRACTOR acknowledges that it is responsible for the payment of all charges and taxes applicable to the services performed under this Contract, and the CONTRACTOR agrees to comply with all applicable laws regarding the reporting of income, maintenance of records, and all other requirements and obligations imposed pursuant to applicable law. If the CITY is assessed, made liable, or responsible in any manner for such charges or taxes, the CONTRACTOR agrees to hold the CITY harmless from such costs, including attorney's fees.
- **B.** In the event the CONTRACTOR fails to pay any taxes, assessments, penalties, or fees imposed by any governmental body, including a court of law, then the CONTRACTOR authorizes the CITY to deduct and withhold or pay over to the appropriate governmental body those unpaid amounts upon demand by the governmental body. It is agreed that this provision shall apply to taxes and fees imposed by City ordinance. Any such payments shall be deducted from the CONTRACTOR's total compensation.
- **C.** The CONTRACTOR, at its expense, shall obtain and keep in force any and all necessary licenses and permits. The commercial general liability policy shall be on an occurrence basis and shall include an endorsement naming the CITY as an additional insured and stating that coverage under such policy is primary over and non-contributory with any insurance the CITY may maintain. CONTRACTOR may satisfy the above insurance requirements with evidence of a program of self-insurance. CITY's Risk Manager's written approval of such evidence of self-insurance will satisfy this provision.

11. Nondiscrimination

The CONTRACTOR agrees to take all steps necessary to comply with all federal, state, and City laws and policies regarding non-discrimination and equal employment opportunities. The CONTRACTOR shall not discriminate in any employment action because of race, religion, creed, color, national origin or ancestry, sex, gender identity, sexual orientation, age, marital status, familial status, veteran or military status, the presence of any sensory, mental or physical disability or the use of a trained dog guide or service animal by a disabled person. In the event of non-compliance by the CONTRACTOR with any of the non-discrimination provisions of this Contract, the CITY shall be deemed to have cause to terminate this Contract, in whole or in part.

12. Conflict of Interest

No officer, employee or agent of the CITY, nor any member of the immediate family of any such officer, employee or agent as defined by City ordinance, shall have any personal financial interest, direct or indirect, in this Contract, either in fact or in appearance. - 2. Provide space for meetings and convening.

- 4. Manage the NEA award including reporting and submitting invoices for reimbursement.
- 5. Cover any costs associated with the grant until reimbursement occurs.

Explanation: The required expenditure is for a one year extension of the existing contract with First Transit that commenced on July 1, 2012.

BACKGROUND:

Pierce Transit requests authority to execute a contract extension for Specialized Transportation Services with First Transit, Inc. based on an hourly service. Pierce Transit's SHUTTLE service is currently operated using a mix of directly operated service and contracted service. SHUTTLE is a shared-ride service for people who, because of their disability, are unable to ride a regular Pierce Transit bus. SHUTTLE provides door- to-door service, or in some instances, transportation to transit centers or bus stops to connect with regular bus service. First Transit provides the contracted SHUTTLE service.

The original agreement allows for an extension by mutual agreement of the parties. Pierce Transit staff analyzed the existing contract terms and conditions, cost, and upcoming changes to this service, and concluded that additional

time under the existing contract with First Transit was needed to allow the Agency to issue a comprehensive RFP for paratransit service. Pierce Transit is currently seeking to add significant upgrades to our on-board technology for this service which should positively impact productivity and that will alter the parameters of the service significantly. These productivity factors will need to be incorporated into the forthcoming RFP and 5 year base agreement by July 2018. With this in mind, Pierce Transit staff approached First Transit seeking to negotiate a one year extension to the contract.

The proposed contract extension also includes a cost of living adjustment of 2.2% based on the Seattle-Tacoma-Bremerton Index and an additional amount of 2.2% to bring the rates current based on new minimum wage and paid leave ordinances enacted by the City of Tacoma and with the Washington State minimum wage laws which increase over 50% between 2016 and 2022. These cost increases were forecast and were included in the 2017 Pierce Transit budget. These increases are reasonable and appropriate.

First Transit has met all existing contract requirements and has provided good service, including the hiring of a Disadvantaged Business Enterprise (DBE) which assists Pierce Transit in meeting those FTA mandated goals.

ALTERNATIVES:

Do not approve this Amendment. If the amendment is not approved Pierce Transit will immediately seek proposals to operate this service and risk limiting competition and receiving proposals that do not include the productivity improvement gains anticipated with the new dispatch technology.

RECOMMENDATION:

Authorize the Chief Executive Officer to enter into and execute Amendment No. 5 with First Transit, Inc., (Contract No. PT-01-012) to provide ADA Paratransit Services through June 30, 2018 in the amount of \$5,584,800.

Explanation: 2017 Budget includes funding for a Feeder Service Pilot project; however, MOD Sandbox grant funding was awarded after the 2017 Budget was finalized, so was not included therein. MOD Sandbox award is \$205,922 and will be added to the Feeder Service Pilot budget to fully fund the project.

BACKGROUND:

Pierce Transit staff seeks authorization for the Chief Executive Officer (CEO) to execute the FTA Sandbox Mobility on Demand Grant Agreement and approve a pilot feeder service project. The Feeder Service Pilot project will require additional contracts within the scope of the CEO's approval authority including agreements with: our transportation network provider Uber (which is currently being negotiated); and a wheelchair accessible vehicle trip provider, for which a RFP has recently been issued.

Project Profile

Pierce Transit (PT) proposes a demonstration project to test a three-pronged approach to provide riders access to transit through first/last mile solutions via rideshare partners; guaranteed ride home when traditional service is unavailable; and rides to and from Park & Ride lots. Based on an average trip cost of \$11, connections will be offered in the following ways:

- The first approach is a first/last mile solution, and refers to those riders needing transportation to or from transit because their start or end point lies beyond a half-mile from nearest transit access. PT will collaborate with a rideshare partner to provide first/last mile service in and between select zones. Riders will request their connecting ride via a rideshare app. These rides will be fully subsidized using grant funds through the grant period. The subsidized rides will be provided only within and between designated zones and to specific bus stops, a transit center or a Sound Transit station (during peak commute hours).
- The second approach is a guaranteed ride home which refers to those riders travelling home after transit service has ended for the evening. These rides will be provided at a cost to the rider equal to standard transit fare with remaining trip cost (rideshare partner trip cost minus standard fare) covered by grant funds.
- The third approach will provide trips to and from Park & Ride lots and Sounder Transit stations to reduce crowding at the lots. These rides must begin or end within 5 miles of the Park & Ride /station, and occur during peak commute hours on weekdays. These trips will be fully subsidized by grant funds for the grant period, and these riders will be using transit to continue their journey.

These services are aimed at increasing throughput at stations served by parking-constrained Park & Ride lots, providing connections to existing bus routes, and providing rides home outside of regular service hours. The zones in this pilot are generally in lower density areas that are not well served with fixed route bus services. At an estimated \$11/trip on average, these rides should be more cost-effective than prior fixed route demonstration projects. This pilot will test another mode to provide transportation services to underserved groups using the latest technology available. Trips will be provided by Uber, our partner in this effort.

Equity/Accessibility

This project provides equitable geographic access to transit for riders who have limited or no transit options, and extended service hours for those who would otherwise be unable to use transit for their return journey. In addition, Pierce Transit focuses on the needs of all travelers in order to ensure that we measure the project's impact on all segments of our ridership.

Accessibility for those with limited mobility

For those riders who would like to take advantage of this service and whose trips start or end in the prescribed zones, but are unable to ride in our partner vehicles (such as those unable to transfer from a wheelchair), the project will aim to coordinate response using contracted wheelchair accessible vehicles.

Access to a smartphone-based system

Our customer satisfaction survey conducted in 2014 indicated that 64% of customers used smartphones. On our next survey to be conducted later this year, we anticipate some increase in the number of riders with smartphones; this could indicate a significant audience for this pilot. However, elders and low-income riders may not have access to or feel comfortable using a smartphone.

For telephone access, Uber plans to provide UberCentral in conjunction with our project launch, which will allow our customer service representatives to make ride requests via Uber on behalf of the unbanked or those without smartphones.

We will also provide outreach and training to communities that may not be familiar with using Uber and/or a smartphone. Proposed outreach methods include a how-to video to be posted on our website, social media posts, and presentations/demonstrations at senior centers and community events.

Improving low income access

Approximately 44% of our ridership is from households with annual incomes below \$20,000. This population may not have access to credit cards or bank accounts, otherwise known as "unbanked". This may limit this population's ability to utilize car-share services.

In order to use an app-based service, a customer must set up an account and a payment method online (either via a smartphone app or using a website on their computer). For those without access to a credit card, an Uber account may be established using PayPal as the payment method, which can be linked to a bank account.

For those without a credit card *or* bank account, Pierce Transit will provide a customer service line, utilizing the UberCentral platform, to request a ride. Trips coordinated using this method will be billed directly to a Pierce Transit account, taking the burden of setting up an account off the unbanked or low-income user.

Community Engagement

Community engagement and outreach of any new service is important to build awareness of that service. Staff has developed an outreach and marketing plan in conjunction with project partners. Outreach includes:

Awareness/Education

- 1. Postings: PowerPoint and/or printed maps, pictures, and text used during meetings to share information with general public, posted in high-traffic public areas in zones.
- 2. Website: Share maps, pilot project description and process, and link to Uber app.
- 3. Pop-ups on Uber app to promote service to regular Uber users, drivers
- 4. Presentations to Pierce College students & faculty, Chambers, Rotary clubs, Church organizations, YMCA, Senior centers, Business districts, Tacoma neighborhood associations
- 5. Media features including The News Tribune & other papers, Pierce County News, CityLine Tacoma TV

WHEREAS, the Community Development department, tasked with creating community partnerships in support of innovative solutions and economic development, has proposed a demonstration project in conjunction with a Transportation Networking Company partnership; and

WHEREAS, examination of accessibility in the service area and community requests for service revealed a need for feeder service to provide connections to transit to those living in zones with limited or no service; and

WHEREAS, in October 2016, Pierce Transit was one of eleven transit agencies awarded the Federal Transit Authority's Mobility On Demand Sandbox research grant funding in partnership with Sound Transit, Uber and Pierce College Puyallup; and

WHEREAS, Pierce Transit has designed the Limited Access Connections pilot project (not to exceed one year) to provide rides in specified zones to and from transit centers, bus stops and Sound Transit Sounder Commuter Rail Stations in order to reduce congestion at park and ride lots, increase transit ridership amongst those living beyond ½ mile of a transit route, and guarantee rides home for those travelling outside normal fixed route service hours; and

WHEREAS, agreements with Uber and a wheelchair-accessible vehicle provider are forthcoming in order to provide accessible and equitable service in support of this pilot; and

NOW THEREFORE, BE IT RESOLVED by the Board of Commissioners of Pierce Transit as follows:

<u>Section 1</u>. The Board of Commissioners hereby authorizes the Chief Executive Officer to enter into and execute the grant agreement for FTA Mobility On Demand Sandbox Research Funding as attached hereto as Exhibit A; and

<u>Section2</u>. Authorizes a pilot project for Limited Access Connections as described herein, not to exceed one year.



Explanation: This amendment increases the Capital Project Support Vehicle Replacement 2017 and authorizes the purchase of eleven support vehicles. The additional requested funds are available from capital reserves.

BACKGROUND:

The 2017 Capital Budget includes funds to replace existing vehicles that meet the replacement parameters (10 Years or 150,000 miles) and are beyond their useful life. One (1) Marketing, one (1) Facilities, two (2) admin/relief, two (2) Shuttle supervisor, and five (5) service supervisor support vehicles are an average of 13-years old with average mileage of 107,764. Replacing the vehicles will help mitigate major component failures, downtime, and

unplanned maintenance cost. The State of Washington has established vehicle contracts that allow for use by political subdivisions. Staff has reviewed the contracts available and has identified the vehicles appropriate for our intended purpose. State Contract pricing is obtained on a competitive bid basis and is considered to be fair and reasonable.

ALTERNATIVES:

The alternative would be to develop specifications and solicit bids ourselves; however, in the past we were not able to achieve the same discounts offered in the state contracts due to combined statewide volume. The second alternative would be to not replace any of the support vehicles. However, these vehicles are beyond their useful life and will require higher maintenance costs.

RECOMMENDATION:

Approve Resolution No. 17-011, amending the 2017 Capital Budget to increase the support vehicle replacement 2017 project and authorizing the purchase of eleven (11) support vehicles, as described above, from Washington State Contract Nos. 02511 and 05916.
