People who live in Pierce Transit's service area and park at Tacoma Dome Station (TDS) now have a reserved parking option.

Parking Permits

In response to increased parking demand, Pierce Transit offers an option to make your transit commute easier. Parking permits are available to public transportation users who park single-occupancy or carpool vehicles at the popular Tacoma Dome Station on weekdays, between the hours of 4 a.m. - 9 a.m. Up to 200 parking permits are initially available for reserved parking, leaving the nearly 2,200 remaining parking spots open for free parking on a first-come, first-served basis in the Tacoma Dome Station facility.

A permit gives you dedicated parking access on weekdays during the morning rush hours of 4 a.m. - 9 a.m.

Permitted spots become available to all parkers after 9 a.m. and on weekends (except during special events).

During special events, everyone parking in the garage must pay the special event fee, and the permitted spots have no reserved status. See inside for details about the three types of monthly permits offered.

How the Program Works

Diamond Parking Services manages permit sales and enforces the program. To apply for a permit, visit PierceTransit.org/resources/permit-parking, then click on the link to Diamond Parking's website. For customer service or to apply for a permit by phone, call Diamond Parking at 1-800-828-4197.

To hold a permit, parkers must ride a bus, vanpool or Sounder train that operates to or from the parking facility, at least 12 times per month. ORCA fare card numbers or Vanpool Commuter ID numbers must be provided by each person named on a permit, to allow for verification of the transit ride requirement. If the requirement is not met, a permit may not be renewed for the following month. Permit holders must also reside within the Pierce Transit benefit area. To see if your address is within the boundary, visit PierceTransit.org/resources/permit-parking.

Visit soundtransit.org to find out if you're eligible for ORCA LIFT, and the nearest location to enroll and get your card. Note that ORCA LIFT is not a Pierce Transit program and ORCA LIFT is not a valid local Pierce Transit fare media.
