5 6	WHEREAS, the Revised Code of Washington 36.57A provides the Board of Commissioners the	
7	authority to set fares; and	
8	WHEREAS, the 2022 Legislative Session of the Washington State Senate passed Move Ahead	
9	Washington, a 16 year transportation package, authorizing Transit Agencies funding to provide free youth	
10	trips on all modes of service offered; and	
11	WHEREAS, Staff presented to the Board of Commissioners in April of 2022 the details of the grant and	
12	the process moving forward; and	
13	WHEREAS, CTAG was informed at their April meeting of the upcoming amendments and details of the	
14	state grant; and	
15	WHEREAS, Staff received feedback on the proposed language presented to the Executive Finance	
16	Committee on May 13, 2022; and	
17	WHEREAS, Pierce Transit has been participatory in regional groups and conversations regarding the	
18	implementation and roll out of the Free Youth Transit Pass to ensure coordinated efforts; and	
19	WHEREAS, Pierce Transit provided public notice for a public hearing on June 29, 2022; and	
20	WHEREAS, the Board of Commissioners held a Public Hearing on July 11, 2022 and received community	
21	input indicated a desire for improved public transit services; and	
22	NOW THEREFORE, BE IT RESOLVED by the Board of Commissioners of Pierce Transit as follows:	
23	Section 1. The Board of Commissioners authorizes Exhibit A as the revised amendments to Pierce	
24	Transit's Code Section 3.72.	
25	Section 2. The adoption of the Free Youth Transit Pass through the Transit Mobility Grant	
26	authorized under RCW Chapter 47.66 Section 422 is in perpetuity of the lifetime of the funding allocation	
27	and distribution to Pierce Transit.	
28	Section 3. The free youth transit trips are effective on September 1, 2022 and each trip shall be	
29	documented in the appropriate fare system log.	
30	Section 4. The Board of Commissioners moves for Final Acceptance of the Title VI Fares Equity	
31	Analysis dated July 11, 2022 as Exhibit B .
